

Transition phase – bid submission

During transition and until Go-live, the following bid types will be fully supported:

- Simple bids fully divisible
- Technical linked bids with same price, direction and resource
- Maximum duration and resting time
- All bids will be available for both direct and scheduled activation



Transition phase – complex/conditional bids

During transition and until Go-live, the TSOs plan to treat complex bid attributes and conditional linking as follows:

- Exclusive bids: only bid component with highest volume will be used
- Multipart bids will be treated as independent simple bids
- Inclusive bids will be treated as independent simple bids
- Conditionally available linked bids will be handled as independent simple bids
- Conditionally unavailable linked bids will be rejected

Transition phase – other new bid attributes

The following bid attributes can be sent but will not be used before Go-live:

- Period shift
- Non-standard product, slower activation time
- Faster activation time (Norway)



Transition phase to Go-live – special cases

Bid submission:

- BSP should submit all components of a complex bid in the same message
- BSP should not change complex ID for a bid
- BSP should not change the technical link ID for a bid

Electronic ordering:

 BSP should not reject a period in the middle of an activation, this will cause issues
