Timeschedule for mFRR transition in new format (CIM)

- mFRR transition in new format (CIM) testing with Bsp's has already started from 01. Nov.2022.
- Testdates for acceptance testing with BSP is already sent to all BSP's along with Testplan and testscenarios.
- Many BSP's have already informed us that assigned time schedule is difficult to attain. Software development is still in progess at their end and they need more time for stabilisation of their product and systemintegration test.
- I have/ will send **new testdates** for 'Acceptance testing with BSP', for all BSP's who want to reschedule their testing dates.
- I will also send dates for 'Verification test in production' with operator in Landsentralen.
- 'Verification test in production' with operator is planned to be executed 5-6 days after 'Acceptance testing with BSP' har status OK.
- Test dates for testing with operator is setup as a proposal and might change as per BSP's or Operator's availability or requirement.
- When 'Verification test in production' with operator has status OK, then that BSP has transcented :-)
- BSP can now send mFRR bid and Activation in CIM format in production. :-)





Testing steps for transition

- Statnett-PT test environment is used for testing with the BSPs test environment to send messages to each other.
- All the testscenarios happy-go-path and negative testing will be exceuted together with Statnett Testleder and BSP's.
- When all mandatory testscenarios has status OK, then that BSP is ready for final verification -Verification test in production with the operator from Landsentralen.
- If there are any testscenarios which is not in testlist, than we would like to run those testcases also when suggested by BSP's.
- When 'Verification test in production' with operator has status OK, then that BSP has transcented :-)
- BSP can now send mFRR bid and Activation in CIM format in production. :-)


- Today we have published a new deadline for Statnett Transition milestone (SN1); April.28.2023
